## North West Grade 12 Learners Declares To Uphold **Examination Regulations**

The North West Grade 12 learners in a fully capacited hall of Waterkloof Secondary School near Rustenburg declared to uphold the examination regulations of not committing any irregularities in the examination centres during the Provincial Prayer and Pledge Signing held on Friday, 17 October 2025.

The primary purpose of the Provincial Prayer and Pledge-Signing ceremony is for the learners to embark on a commitment to conduct themselves in the highest possible manner during the examinations without committing any irregular activities like cheating in the examination centre.

The Kloofwaters Secondary School Hall was filled to capacity with different stakeholders who came to pray and witness the pledge signing namely; Traditional Leaders, Members of Parliament, Councillors, Pastors, Departmental Officials, Principals and Educators, School Governing Bodies, Unions, Business Stakeholders and Learners.

The MEC for Education, Viola Motsumi emphasized that the incidents of vandalism create setbacks that communities cannot afford. "We are living in a very critical and challenging time, where the actions of a few continue to harm the future of many. It is deeply troubling that criminals persist in destroying and stealing the property of our schools and communities. Just recently, at Boitekong Secondary School not far from here, a block of classrooms was set on fire. In other schools, food for learners, vital resources such as computers and educational equipment have been stolen. These acts of vandalism and theft are not only criminal; they are an attack on the education and future of our children. They delay progress, undermine the limited infrastructure we have, and create setbacks that our communities cannot afford. Many of our schools already operate with minimal resources and what little we have has been hard-earned and paid for through sacrifice and effort", said MEC Motsumi.

MEC Motsumi further pleaded with communities to take a stand against vandalism. She said communities, leaders, and parents must rise together to protect schools and safeguard the future of learners. She further said, education is a shared responsibility, and it is the duty of everyone to ensure that schools remain safe, functional, and protected spaces of learning and hope.

"This year, I am filled with confidence and high expectations. I believe that our learners are prepared to rise even higher to push beyond and claim a spot among the top three performing provinces in the country. It is within reach, and it is possible with focus, discipline, and a commitment to excellence. As we approach the final examinations, I also want to emphasize the importance of integrity in this process. I trust that our learners will reject all forms of dishonesty and refuse to participate in any irregular or unethical activities during the exams. Let us be known not only for our results, but also for the honesty and values that define us", said MEC Motsumi.

Bonginkosi Motaung the Grade 12 learner and the President of the North West Representative Council of Learners pleaded with all the Grade 12 learners to obey the examination rules. "I am pleading with my fellow learners to obey the examinations rules by not committing any silly action which will put them in trouble. Learners must believe in themselves and work hard to be the better people in future. My fellow colleagues should live up to the pledges that they have committed today until the end of examinations", said Motaung.

A Grade 12 Learner who could be found to have committed an irregularity during the examination can be banned from writing examination for a period of three years by the Department of Education. This ban means the learner cannot write the National Senior Certificate (NSC) exam that period, which has significant consequences of the future education plans.

## MEC Motsumi Motivates Grade 12 Learners At Charora Secondary School

The North West Department of Education MEC, Viola Motsumi, when concluding the Last Push campaign before the examinations, visited Charora Secondary School near Luka Village near Rustenburg to motivate both parents and Grade 12 learners on Saturday, 18 October 2025.

The visit followed the low performance of Charora Secondary School in the third-quarter matric results, wherein they obtained 63.5 %. The school has a total number of 159 Grade 12 learners, and 59 learners failed in the third quarter.

Parents and learners committed to helping learners during this period of the final examination. During the Pledge Signing, parents played an important part in the commitment. The MEC for Education, Viola Motsumi, pleaded with parents to release learners to attend the incubation camps.

"I am extremely pleased to see a large number of parents who have responded to a call on Saturday morning. This action shows that parents of this school have a kin interest in education.

"In the last quarter we have observed that when learners were writing their examination being hosted in the incubation camp, they passed their exams. When they write exams being home they are defocused and many learners fail. I am appealing with your good selves to bring learners to the incubation camps. Teachers are available at the camps to assist learners and we are still hopeful that results could improve", said MEC Motsumi.

Ms Mapule Khunou a mother of the Grade 12 learner highlighted that as parents they never had education but they are willing to assist their children.

MEC Motsumi further made an awareness to the Grade 12 learners, that any learner who will be found to have contravened with the examination rules will be banned for a period of 3 years

# Third Day of the NSC Examination Runs Smoothly in North West Province By Mphata Molokwane

he MEC of the North West Department of Education, Viola Motsumi, expressed satisfaction with the third day of the National Senior Certificate (NSC) examinations, commencing with the learners writing English Paper 3.

MEC Motsumi today went to motivate learners and monitor examinations at MpheBana Secondary in Koster, where 189 matric candidates sat for examination. Following the examination monitoring, Motsumi called a meeting with the School Management Team (SMT) and School Governing Body(SGB) to deliberate on the proposed strategy for the incubation of all candidates. The incubation process is arranged to start on Sunday, 26 October 2025.

During this examination period, the North West will station subject advisors to assist the school with the incubation programme to support all candidates, as they have consistently performed below 80% throughout the year.

Motsumi emphasised that school must work closely with the parents during the incubation camp for teachers to be able to concentrate on the curriculum. "The incubation camp will allow teachers to give more time to curriculum delivery while parents partner with the school to foster a conducive environment for learners. We remain committed to supporting every candidate and will continue to monitor examination processes until the last paper is written", says Motsumi.

Candidate will finish writing their examinations on the 28th of November 2025.

# MEC's Special Meeting With Curriculum Directorate And The District Officials

The North West Department of Education, MEC Viola Motsumi, called a special meeting on Tuesday, 21 October 2025, with the district officials and Curriculum Directorate. The meeting was held at Ga-Rona building in the Executive Boardroom.

The main objective of this meeting was to analyse the Grade 12 Term Three preliminary examination results and to check the state of readiness for NSC learners and come up with an intervention strategy which will help grade 12 learners to achieve 95%.

In this meeting, MEC Viola Motsumi emphasized the importance of collective effort in obtaining the set target of 95%. There has been a minimal increase of 10.1% in comparison to the 2024 cohort and a 9.1% increase compared to 2023. The province currently, after analysing these results, is achieving an 84% pass rate, with only 4,115 out of 41,924 matric candidates remaining to meet the targeted percentage.

MEC Motsumi is very pleased with the outcomes presented before her and she further appealed to communities to desist from disruptive activities of protests as this can deny learners access routes to schools, which could avert candidates from writing their examinations. "We are within reach of our 95% target, though we cannot be complacent. Every learner matters. We call on parents, teachers, district officials, and community leaders to work with us, ensure uninterrupted access to schools, and protect examination schedules from disruptive protests," says MEC Motsumi.

The departmental officials highlighted that targeted interventions such as incubation camps will continue in schools and districts where candidates still require more support.

## Exams in the North West Starts and Continues Smoothly With No Obstacles Recorded

The North West Department of Education reports that it had a smooth start of the 2025 NSC examinations. On the 21st of October 2025, 2,760 registered National Senior Certificate (NSC) candidates for Computer Applications Technology (CAT) P1 (Practical) wrote well in 89 schools across the province. The paper was well monitored, and all schools were covered. There are no major challenges that were reported during the writing of the first paper in all centers.

MEC Viola Motsumi conveyed her satisfaction with the smooth start of the examination process at these eighty-nine (89)schools. "It is promising to mention that our learners are receiving the necessary support to excel in their examinations. We expand our best wishes for their continued success as they progress, and we remain committed to ensuring that every learner is given a fair and equitable opportunity to attain their academic aspirations in this examinations," says Motsumi.

NSC Examinations will conclude on the 28th of November 2025.

# North West Department Of Education Terminated Contracts Of BEEI EA/GA at End Of November 2025

The North West Department of Education issued letters to the Basic Education Employment Initiative (BEEI) Educational Assistants and General Assistants to notify them about the termination of their contracts at the end of November 2025 instead of December 2025.

The BEEI project was implemented in June 2025 throughout the country, but the North West Province only started in July 2025 due to recruitment challenges experienced. These challenges forced the province to delay the appointment of the EAs and GAs in June and to appoint them at the beginning of July 2025. Among the recruitment challenges experienced were the exclusion of the SGBs in the establishment of interview panels, non-compliance with the radius (5 km and 30 km), and the selling of the BEEI posts, etc.

The North West Department of Education made an application through the Department of Basic Education to the Unemployment Insurance Fund for an extension of the programme by one month. The Department of Basic Education indicated that the application for the extension was not approved by the funder.

The North West Department of Education was subsequently advised to notify the Educational Assistants and General Assistants of the outcome of the request. The Department then issued notices to the affected individuals a month before the actual date of 30th November. The MEC for Education, Viola Motsumi, emphasized that it is extremely unfortunate that the funder did not approve the request of the North West province.

"On behalf of the North West Department of Education, I am extremely disappointed that the funder of the BEEI programme did not respond to our request to extend the programme by one month. Our province could not start with the programme in June due to a myriad of challenges experienced in different schools. In June, we were forced to clean up all those problems wherein some posts were sold to the youth.

"We viewed these as serious challenges, and as a result, we could not start the programme in June 2025. I want to inform our youth that this programme is not funded by the Department, nor does the budget reside with the Department. On a monthly basis, it is the funder who transfers the money into the Educational Assistants' and General Assistants' accounts. When the funder said the programme is closing in November in all provinces, we do not have powers to act contrary to the funder," said MEC Motsumi.

MEC Motsumi further pleaded with the Educational Assistants and General Assistants to understand the position of the Department and to work together in sharing this information with the youth in all the schools.


"I want to thank all the Educational Assistants and General Assistants who have been deployed to our schools. Your contribution does not go unnoticed, but it is felt by all teachers, learners, and departmental officials. Our schools will not be the same without you. In this short period of time, your contribution has been so immense, and you have been a great relief to our teachers. I am requesting you to share this information with all other colleagues in different schools," added MEC Motsumi.

The Educational Assistants' and General Assistants' last day at school will be the 30th of November 2025.

- Incorporate physical activity into your routine to help focus and mange stress.





# Feedback Session On Annual Performance Evaluation Of Conditional Grants

The Department of Basic Education organised a two-day feedback session which was held at Sun City Resort in the North West Province. The session, which focused on the performance and evaluation of Cluster 1 conditional grants, was held on the 15-16 October 2025 and has in attendance all grant-driven segments of the DBE from the three provinces which constitute the North West, Mpumalanga and Western Cape Provinces. The objectives of the session among others were:

- Analysis of past performance of all sectors concerned,
- Understanding of the scope and challenges,
- Strengthening implementation through impactful intervention and
- Strengthening synergy across conditional grants.

Conditional grants are a transfer of funds from a central government to a lower entity aimed to drive a specific and predefined purpose; so the Cluster has sat to verify if their implementation in various provinces met their stipulated goals through proper and required performance. Sectors affected include among others; Mathematics, Science and Technology (MST), Learners with Severe to Profound Intellectual Disability (LPID), Early Childhood Development (ECD), Life Skills HIV/AIDS, Education Infrastructure Grant (EIG) and National School Nutrition Programme (NSNP).

The North West Department of Education Superintendent General, Mr. Lengane Bogatsu opened the session by igniting a song "Ga a yo mathata"; that was done to uplift the mood of attendees alternatively signaling triumph for when people work together under God's guidance. He emphasized that when a mind and body are healthy, there is no way that sectors can fail. "People need to take note of the every person's contribution in the system to make a team that work. We must work together to complement each other!". He also requested the attendees to align their work approach with McKinsey's 7-S Model. The model stresses interdependence in an organisation which helps to assess and improve its effectiveness.

The Model talks to the organisational elements which are strategy, structure, systems, shared values, skills, style and staff. Aligning the organisation objectives to these elements, always helps to ensure that company's goals are supported and ultimately met. "People need to understand what is expected of them, so that they can perform well. The Cluster must always conduct peer review sessions in order to assess their work, see to it that there is compliance with prescripts and requirements, and ultimately achieve the intended goals." He further emphasised that the Division of Revenue Act (DORA) is central to what the Cluster is doing, therefore implementation must always be aligned to it.

#### Findings and Strategies

The three provinces have presented their findings and came up with mitigations throughout the two days of the event. The presentations highlighted the challenges which mostly cut across the provinces, as well as the strategies to fend off the persistence of the problems. The general outlook of the findings and mitigations from the session is as follows:

- Implement safety awareness and emergency preparedness training for teachers
- MST CG beneficiary schools to participate in endorsed CG competitions

# North West Department Of Education Advances School Sanitation And Water Access In Fafung Village Schools

The North West Department of Education on Friday, 24 October 2025, conducted an oversight visits during the Phase Five Thuntsa Lerole Reloaded Programme to assess critical sanitation and water projects in Fafung Village, Madibeng Local Municipality.

The Department inspected the construction of a new sanitation block at Rekopantswe Secondary School and monitored progress on the borehole water drilling at Molelwane Primary School. Following the assessments, fifty (50) dignity packages were donated to learners at Rekopantswe Secondary School.

Restored and reliable access to water is anticipated to improve hygiene, permit regular hand washing, and support everyday school processes. The MEC for Education, Viola Motsumi emphasized that, the aim of the Department is to ensure projects are delivered on time.

"We are dedicated to guaranteeing that every single learner has access to the basic amenities desired to learn within safety environment and dignity. These oversight visits are important to guarantee projects are delivered on time and with high standard.

The donation of dignity packages is a noticeable indication of our continuing support for learners," says Motsumi.

The Department will continue to work with contractors, school governing bodies, and community members to oversee progress and resolve challenges as they arise.
